# JOONDALUP UNITED FOOTBALL CLUB (JUFC)

**TERMS & CONDITIONS** 

I, THE UNDERSIGNED, accept the following terms and conditions of membership to the Joondalup United Football Club:

### **Payment of Registration Fees**

All fees must be paid in full prior the approval of registration. In exceptional hardship circumstances, JUFC may consider a payment plan option. Payment plans must be agreed in writing with JUFC's Executive at time of registration.

#### Procedure for Player Suspension for non-payment of fees

If after payment deadlines have passed and/or payment plans are not adhered to, the Committee will take action to suspend a member from playing with the club until such time as corrective action has been taken to bring outstanding fees up to date. This will always be a last resort of the Committee and would only happen if previous communications with members have been ignored. Please note if a team has to forfeit due to player availability, then some or all of this fine may be passed on. The decision to suspend player/s from participating can only be proposed by the Treasurer in consultation with the Junior Co-ordinator. The player/s will be contacted, in writing, 24 hours before the next game and informed of the decision. The player's coach will also be advised at the same time. The player/s may only be allowed to play again at the recommendation of the Junior Co-ordinator and the Treasurer once they have fulfilled the agreed requirements for payment. All player registration payment details will be kept strictly confidential between the above Committee members, the coach, and the member concerned.

#### Refunds

No registration refunds will be given after a player has been graded and allocated to a team. Partial registration refunds may only be given at the discretion of the Committee in exceptional circumstances e.g., severe injury, excluding unrecoverable costs ie, FFA and Football West (FW) components. No refunds will be provided if membership is revoked due to breaching JUFC Codes of Conduct.

### Procedure for Player Fines/Red Cards

Players who are suspended by Football West for disciplinary actions or red cards are personally responsible for payment of all fines and will be ineligible for selection until the fine/s is paid in full and penalties served. Depending on the nature of the fine or red card, JUFC retains the right to impose additional fines or bans at the discretion of the Committee. **Unpaid fines** will be carried over to the next season and the member will not be eligible for registration until unpaid fines are paid in full. A position in the team will **NOT** 

be held. If the fine remains unpaid FW will be notified to ensure the player is not registered at another club while outstanding fees or fines remain unpaid. All correspondence to JUFC must be made in writing.

# **Privacy Policy**

Personal information collected by JUFC is for the primary purpose of membership requirements and/or competition. I/We give permission to use football match photos of our son/daughter in the Club Newsletter, Club Webpage, Club Facebook Page, Club Instagram Page and Club Marketing.

If you do not grant permission for your child's football match photos to be used in the Club Newsletter, on the Club Website, Facebook Page, Instagram Page, or in any Club marketing materials, please make sure to indicate this on the Membership form.

## **Duty of Care**

I/We confirm I/we have informed JUFC of any behavioural conditions which may affect JUFC's duty to manage the safety and injury prevention of the player or other players. I/We confirm that a responsible adult WILL be present at all training sessions and matches if JUFC considers it necessary to manage the safety of the player or other players. I/We exclude JUFC from liability relating to injury of player or players by reason of a responsible adult failing to meet their obligation to attend all training sessions and matches as requested by JUFC.

## **Emergency Treatment**

In the case of emergency, I/We authorise JUFC to arrange any necessary treatment of my child (not applicable if 18 years and over). If a child has a medical condition which is likely to require attention, a responsible adult MUST be present at all training sessions and matches. (Not applicable if 18 years or over).

- VIOLENT AND OR ABUSIVE BEHAVIOUR OF ANY KIND WILL NOT BE TOLERATED BY JOONDALUP UNITED FOOTBALL CLUB.
- All players, parents & coaches will be bound & must abide by the Joondalup United FC
- All players, parents & coaches must abide by the By Laws & the Rules of Competition of Football West.
- All new players must provide a copy of a birth certificate, or previous players supply FW registration number.
- Players will be placed into teams in accordance with player numbers and allocation of divisions by Football West.
- All applications for KidSport Funding assistance must be advised to the club along with approved voucher code.

- That ALL FEES must be paid in FULL, and players must complete an online Football West Registration Form to be eligible to play.
- Limited insurance cover only is available through registration with Football West. Players play at their own risk.
- I give permission for myself/ my child, named on the form, for photographs to be published on the Joondalup United Football Club's website, Facebook pages and associated social media accounts.
- "I understand, agree and undertake to comply with all the conditions, requirements and expectations of the JUFC's Constitution, liquor licenses, policies and codes of conduct, including but not limited to, Code of Conduct for Parents, Coaches and Players and Policies for Child Protection, Complaints, Sport Safe and Smoke Free."
- 2. "I understand and agree that, if I engage in conduct that causes JUFC to be subjected to a fine, penalty or other disciplinary action, then I undertake to pay any fines, penalties and costs of disciplinary action and will comply with any penalties imposed."
